He informed them that it is very hard to get PennDOT paint, so that could make up some of the increase. The motion was made by Aughenbaugh and seconded by Gabriel that Council award the contract to Aztec Linear in the amount of \$39,514.50. Roll call vote was as follows: Dietz, yea; Bernardo, yea; Aughenbaugh, yea; Gabriel, yea; Walsh, yea. Motion passed 5-0.
