## DuBois Memorial Park Improvements DCNR Resolution (Cont'd.)

Authority Director Mitchell stated that this is a grant for basketball and volleyball courts and skate park improvements. The motion was made by Gabriel and seconded by Dietz that Council approve Resolution DCNR-C2P2 – DuBois Memorial Park Improvements as presented. Roll call vote was as follows: Aughenbaugh, yea; Bernardo, yea; Dietz, yea; Gabriel, yea; Walsh, yea. Motion passed 5-0.

#### Councilwoman - Shannon Gabriel

She wanted to stress the importance of the Drug Task Force in the City of DuBois. Mayor Walsh asked if Chief Clark had any numbers. City Manager Suplizio stated that our Finance Officer would put the numbers together.

#### Councilman - Shane Dietz

Wanted to piggyback on to Gabriel's comment: He wanted to know what the process is for people (individuals working with drugs) who are rounded up. Chief Clark stated that the individuals are charged and any money that is found on them is used for processing, if there is more money than the cost of processing after the case is settled the police ask the DA for the money to be released back to them. Gabriel mentioned the new Vent Hood the police had recently acquired. Clark stated it cost \$10,000 and was purchased from some of the funds relinquished by the DA's office. The Vent Hood will allow them to test substances safely without having to send it away for processing. Prior to the Hood it would take up to four months to get the results back; 4 months with the individual free to walk the streets.

#### Councilwoman - Diane Bernardo

Mentioned the new Tasers available – a lasso? Clark doesn't feel the lasso took off like they thought it would. Bernardo asked if Clark is considering purchasing one; Clark wants to see further testing on them before he would commit.

#### **City Solicitor - Toni Cherry**

Bankruptcy - We receive several bankruptcy letters for chain stores that are not located in the City limits. At one time these stores were located at the DuBois Mall. She wanted Council to be aware that even when a store goes into bankruptcy it does not alleviate paying taxes.

# Councilman – Jim Aughenbaugh

- Eastside Building? City Manager Suplizio said he would call Mr. Kepple.
- Pool Project when is it to begin? City Manager Suplizio said not until after the season.

## City Manager - John "Herm" Suplizio

- Top of the Embankment at the end of the boulevard Summer project hoping to be finished by Community Days in June. Councilman Aughenbaugh asked if a picture could be put on the Website. Suplizio confirmed it would be.
- Work will be restarting on Maple Avenue through the end of summer; we should be getting a letter out to residents. Currently, they are doing drainage.

# Councilwoman – Shannon Gabriel

Addressed some comments she had seen recently on Facebook concerning potholes. She wanted people to know they can call into the office and report potholes. She also wanted them to be aware that not all roads in the City of DuBois are City roads. Route 255 and 219 are state roads so people would need to report those to Penn DOT.
