The meeting was called to order at 6:35 p.m. and the Pledge of Allegiance was led by Mayor Walsh.

Approval of Minutes

Work Session Meeting Minutes - August 11, 2022

Recommendation - 2022 Street Paving

The motion was made by Gabriel and seconded by Aughenbaugh that Council accept the recommendation of the City Engineer and award the contract to Glenn O. Hawbaker, Inc. in the amount of \$617,504.00. Aughenbaugh asked if he had to do a lot of trimming. Nasuti stated it wasn't too bad. Walsh asked when the project would take place. Nasuti said it must be completed by the end of October; he'll get the schedule tomorrow from the contractor. Water Resource Recovery Facility – Contract No. 22-01: General Construction

Water Resource Recovery Facility – Contract No. 22-03 HVAC Construction

Water Resource Recovery Facility – Contract No. 22-04 Plumbing Construction
The motion was made by Gabriel and seconded by Dietz that Council accept the recommendation of HRG Engineering and award the contract to Fred L. Burns in the amount of \$1,815,100. Roll call vote was as follows: Dietz, yea; Bernardo, yea; Aughenbaugh, yea; Gabriel, yea; Walsh, yea. Motion passed 5-0.

Water Resource Recovery Facility - Proposal No. 2022-01410

Nasuti stated this would be for the Controls to run the plant. The motion was made by Aughenbaugh and seconded by Dietz that Council accept the recommendation of HRG Engineering and award the contract to Keystone Engineering Group in the amount of \$1,810,000. Roll call vote was as follows: Dietz, yea; Bernardo, yea; Aughenbaugh, yea; Gabriel, yea; Walsh, yea. Motion passed 5-0.

Coke Hill Sanitary Sewer Rehabilitation – Contract No. 22-06; General Construction
The motion was made by Bernardo and seconded by Gabriel that Council accept the recommendation of the HRG Engineering and award the contract to Continental Construction, Inc. in the amount of \$2,264,144. Roll call vote was as follows: Dietz, yea; Bernardo, yea; Aughenbaugh, yea; Gabriel, yea; Walsh, yea. Motion passed 5-0.

Walsh asked what happens next. Nasuti stated that we notify the award winners; they have until September 26 to send their Award Notice back to use; the PennVEST bond closes on October 13th; then we can proceed.

Suplizio stated that Councilwoman Bernardo had already addressed this at the Joint Board Meeting. Arbaugh was unable to obtain an extension for the Sewer Plant. Everyone was very thankful for his attempt.
