7. Police Sub-Committee Presentation - Kris Kruzelak

The PowerPoint has been posted on the Website for everyone to review. Many officers with 20 plus years of experience were instrumental in putting this report together. It mostly has to do with Department Staff, Structure, and Divisions. Currently the City of DuBois has 13 fulltime officers and Sandy Township has 12; he believes this is low for this area. In the plan the organizational chart calls for 35 officers; which would be creating an investigation division that would encompass child abuse cases and narcotics. He feels they will have a problem without more manpower and more manpower means more levels of supervision. They are very happy with the plan but he's not so sure the Finance Sub-Committee will be. He has asked for a two-week review and a discussion about the plan at the next meeting. The motion was made by Kruzelak and seconded by Salandra that the Consolidation Committee hold the PowerPoint for a two-week review and a discussion at the next meeting.
