- B. Continue with the DMAP Program
  Mayor Walsh stated that this is the program that gives out a coupon for an additional doe tag; helps cut the population on the Watershed. The motion was made by Gabriel and seconded by Aughenbaugh that Council accept the recommendation of the Watershed Committee and continue the DMAP Program.
