It looks like fireworks will be prohibited before 10 a.m. and after 10 p.m. with the exception of July 2 - 4 and December 31st which will allow detonation until 1 a.m. Suplizio suggested if she hears them outside of those limitations, she should contact the City police.

Awarded Grant for Traffic Safety - Upgrade light at Park & Brady ST - \$488,000

The City has been awarded a grant through the Pennsylvania Department of Transportation Green Light Go program to help alleviate congestion and traffic flow. City Manager Suplizio stated that this will totally modernize the signal at that intersection.

Update on Maple Avenue

Maple Avenue is now open to Fourth Street. Currently they are working on Fifth through Tenth Street. Hopefully they will be able to pave in two weeks and the project should be completed by mid-September.

Update on Embankment Project

The bids for the second half of the project should come in Monday; we're hoping we can move right onto the other side.

Update on Flood Control Project

We have received a \$720,000 grant to clean the silt out of the Sandy Lick Creek and build up the banks; the project will begin at Liberty Boulevard to DuBois Street.
