WHEREAS, Section 322 of the Disaster Mitigation Act of 2000 (DMA 2000) requires state and local governments to develop and submit for approval to the President a mitigation plan that outlines processes for identifying their respective natural hazards, risks and vulnerabilities, and

WHEREAS, the City of DuBois acknowledges the requirements of Section 322 of DMA 2000 to have an approved Hazard Mitigation Plan as a prerequisite to receiving post-disaster Hazard Mitigation Grant Program funds, and

WHEREAS, the Clearfield County 2022 Hazard Vulnerability Assessment and Mitigation Plan has been developed by the Clearfield County Department of Emergency Management in cooperation with other county departments, officials, and citizens of City of DuBois, and

WHEREAS, a public involvement process consistent with the requirements of DMA 2000 was conducted to develop the Clearfield County 2022 Mitigation Plan, and

WHEREAS, the Clearfield County 2022 Hazard Vulnerability Assessment and Mitigation Plan recommends mitigation activities that will reduce losses to life and property affected by natural hazards that face the County and its municipal governments,

NOW THEREFORE BE IT RESOLVED by the governing body for the City of DuBois:

- The Clearfield County 2022 Hazard Vulnerability Assessment and Mitigation Plan is hereby adopted as the Official Hazard Mitigation Plan of the City, and
- The respective officials and agencies identified in the implementation strategy of the Clearfield County 2022 Hazard Vulnerability Assessment and Mitigation Plan are hereby directed to implement the recommended activities assigned to them.
