COOPERATION AGREEMENT BY AND BETWEEN

THE REDEVELOPMENT AUTHORITY OF THE CITY OF DUBOIS

AND THE CITY OF DUBOIS FOR COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAMS AND GENERAL ECONOMIC AND COMMUNITY DEVELOPMENT ASSISTANCE

This Agreement, made and entered into this 18th day of March 2021, by and between the Redevelopment Authority of the City of DuBois, a body corporate and politic, having its principal office at 16 West Scribner Avenue, DuBois, Pennsylvania, hereinafter referred to as the "AUTHORITY",

AND

The City of DuBois, a corporation organized and existing under the Third-Class City Code, having its principal office at 16 West Scribner Avenue, DuBois, Pennsylvania, hereinafter referred to as the "City".

WITNESS THAT:

WHEREAS, the CITY has requested the AUTHORTY to provide Economic and Community Development Assistance to the City on various projects and Administration of the Community Development Block Grant Program; and

WHEREAS, the City has funding available through the CDBG Program and the Riverside UDAG Payback Account, for various purposes and projects (i.e. economic development, revolving loan fund, etc.), the City shall allocate a portion of these funds for compensation of the staff of the Redevelopment Authority; and

WHEREAS, the AUTHORITY will provide the following services:

COOPERATION AGREEMENT BY AND BETWEEN

THE REDEVELOPMENT AUTHORITY OF THE CITY OF DUBOIS AND THE CITY OF DUBOIS (Cont'd.)

- 1. Investigations of grants, endowments, and loans that may be available to the CITY.
- 2. Preparation of all grant applications and associated documentation (i.e. downtown development projects, CITY infrastructure projects, and CITY departmental projects) in cooperation with the City Manager, Mayor, Council, Public Works Director and CITY Departmental Supervisors.
- 3. Administration of grant applications when the CITY is successful in obtaining funds.
- 4. Preparation of project-specific Request for Proposals for professional services.
- The AUTHORITY shall properly document payment requisitions to the CITY for payments to be made to contractors or for reimbursement if the invoice has been paid by the AUTHORITY.
- 6. The **AUTHORITY** shall be paid by the **CITY** for administration of programs activities, in relation to specific projects including:
 - a. Preparing and submitting required program reports to the funding agency.
 - b. Insuring contract compliance and work performance of all contractors and subcontractors.
 - c. Collections and evaluation of program data for assessment of performance and compliance.
 - d. Respond to the funding agencies monitoring visits and any possible monitoring findings.
- 7. In addition, both parties consent to the following:
 - a. The **CITY** and the **AUTHORITY**, as its agent, will comply with all FEDERAL and STATE rules and regulations pertaining to the activities described herein.
 - b. Either party may terminate this agreement within thirty (30) days following service or written notice; this agreement may be amended in writing, from time to time by the parties hereto to provide for additional program activities and/or services or to redefine said activities or services.
 - c. In addition, the Redevelopment Authority shall be permitted to charge the CITY for mileage at current federal reimbursement rate and actual costs for meals, lodging and other travel/subsistence expenses.
 - d. The funds committed to the Redevelopment Authority from the City of DuBois 2020 CDBG Program Administration activity.
