

City Solicitor Cherry stated that we have a lot of substandard lots in the City of DuBois, we may want to think about modification as a way to make them buildable and put them back on the tax roll.

Councilwoman Bernardo

She had changed seats due to the prior Joint Board Meeting and likes the view from her new seat better.

Councilman Shane Dietz

Stated that our well water is good, it's just not up to our usual standard.

Councilwoman Shannon Gabriel

Wanted to know what the 1.1 gets us; Manager Suplizio stated we will still get the fountain but the pavilion is out. The 1.1 is only getting us about half of what we wanted. We are moving forward with another grant.

Councilman Jim Aughenbaugh

Questioned the Penelec lights still on Maple Avenue. Suplizio stated we were waiting to make sure our lights worked, we can write a letter and try to get them pulled this summer.

City Solicitor Toni Cherry

Talked about a repeat Right to Know that she will take care of answering.

City Manager - John "Herm" Suplizio

- Stated that the work will be beginning again on Maple Avenue we will try to send out another letter next week.
- Asked Public Works Superintendent Farrell to get the stop signs up on Chestnut Avenue astraffic will divert again.
- Thanked Mr. Whitaker and Attorney Gabriel. Went on to say that bringing different personalities together make for very trying times. To repeat what Councilwoman Bernardo said Mr. Whitaker is the right person, at the right time, in the right place. We have to get through it, we have no other choice.
