

City Council Meeting Minutes – November 21, 2022

City Council Chambers, City Building, 16 West Scribner Avenue, DuBois, Pennsylvania on Monday, November 21, 2022 @ 6 p.m.; Council convened at their regular City Council Meeting with Mayor Walsh in the Chair. Stated she is plowing through her assignments.


City Manager Suplizio asked for an Executive Session concerning a Land Sale.
