Resolution No. 2022-0359 - Tax Collector Waive Additional Charge for Real Estate - 1st Yr. (PA Act 57)

RESOLUTION NO. 2022 - 0359

A RESOLUTION OF THE COUNCIL OF THE CITY OF DUBOIS, CLEARFIELD COUNTY, PENNSYLVANIA, REQUIRING THE TAX COLLECTOR TO WAIVE ADDITIONAL CHARGES FOR REAL ESTATE TAXES ASSESSED IN THE FIRST TAX YEAR FOLLOWING THE ENACTMENT OF THE ACT WHERE NOTICE OF THE REAL ESTATE TAXES WAS NOT RECEIVED FOLLOWING THE TRANSFER OF REAL PROPERTY AND THE TAXPAYER SATISFIES ALL CONDITIONS AS SET FORTH IN THE ACT.

WHEREAS, Pennsylvania Act 57 of 2022 ("Act 57") was signed into law on July 7, 2022, by Governor Tom Wolf, and amended Section 7 of the Local Tax Collection Law, 72 P.S. §5511.7, addressing the effect of failure to receive tax notice; and

WHEREAS, Act 57 requires taxing districts that impose taxes on the assessed value of real estate to adopt a resolution or ordinance requiring the Tax Collector to waive additional charges as defined in Act 57 for real estate taxes under certain circumstances beginning in the first tax year after the effective date of Act 57; and

WHEREAS, the Department of Community and Economic Development shall develop and make available to each taxing district a form by which a taxpayer may request a waiver of Additional Charges as defined in Act 57.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The Tax Collector shall, for tax years beginning on and after January 1, 2023, grant a request to waive additional charges for real estate taxes in the then current tax year, if the taxpayer completes all of the following:
 - A. Provides a waiver request of additional charges to the Tax Collector in possession of the claim within twelve (12) months of a qualifying event;
 - B. Attests that a notice was not received;
 - C. Provides the Tax Collector in possession of the claim with one of the following:
 - i. A copy of the deed showing the date of the real property transfer; or
 - ii. A copy of the title following the acquisition of a mobile or manufactured home subject to taxation as real estate showing the date of issuance or a copy of an executed lease agreement between the owner of a mobile or manufactured home and the owner of a parcel of land on which the mobile or manufactured home will be situated showing the date the lease commences; and
 - D. Pays the face value amount of the tax notice for the real estate tax with the waiver request.
- ${\tt 2.} \quad \hbox{A form providing for the waiver request of additional charges will be made available from the Tax Collector.}$

- 3. A taxpayer granted a waiver and paying real estate tax as provided in Act 57 shall not be subject to an action at law or in equity for an additional charge, and any claim existing or lien filed for an additional charge shall be deemed satisfied.
- 4. The Tax Collector accepting a waiver and payment in good faith in accordance with this Resolution and Act 57 shall not be personally liable for any amount due or arising from the real estate tax that is the subject in the waiver.
- 5. As used in this Resolution, the following words and phrases shall have the following meanings given to them unless the context clearly indicates otherwise:
 - A. "Additional Charge"
 - i. Any interest, fee, penalty, or charge accruing to and in excess of the face amount of the real estate tax as provided in the real estate tax notice.
 - B. "Qualifying Event"
 - i. For the purposes of real property, the date of transfer of ownership.
 - ii. For the purposes of mobile or manufactured homes, the date of the transfer of ownership or the date a lease agreement commences for the original location or relocation of a mobile or manufactured home on a parcel of land not owned by the owner of the mobile or manufacture home. The term does not include the renewal of a lease for the same location.
 - C. "Tax Collector"
 - i. A tax collector as defined in Section 2 of the Local Tax Collection Law (72 P.S. §5511.1, et seq.), a delinquent tax collector as provided in Section 26.1 of the Local Tax Collection Law, the tax claim bureau or an alternative collector of taxes as provided in the Real Estate Tax Sale Law (72 P.S. §5860.101, et seq.), an employee, agent or assignee authorized to collect the tax, a purchaser of claim for the tax or any other person authorized by law or contract to secure collection of, or take any action at law or in equity against, the person or property of the taxpayer for the real estate tax or amounts, liens or claims derived from the real estate tax.

DULY ADOPTED and enacted this 3rd day of November, 2022.

Police Chief Contract

City Manager Suplizio stated that we need to renew the Chief of Police Contract with the term ending June 30, 2026. After discussion, Council approved the contract but extended the term to December 31, 2026. The motion was made by Bernardo and seconded by Gabriel that Council approve the contract for the Chief of Police extending the term to December 31, 2026. DuBois Area Historical Society Plaques Top of the Boulevard
