WHEREAS, the City of DuBois is familiar with the requirements of the program as provided for in the Housing and Community Development Act (HCDA) and the Community Development Block Grant regulations; and

WHEREAS, the City Council of the City of DuBois wishes to apply for said funds.

NOW, THEREFORE, BE IT RESOLVED, by the City of DuBois that its Mayor is authorized to have prepared necessary forms and documents to submit an application to the Department of Community and Economic Development for Community Development Block Grant (CDBG) funds for the purposes aforesaid; and

BE IT FURTHER RESOLVED, that the Community Development Plan was developed in coordination with low- and moderate-income individuals, interested organizations, non-profits and other interested parties through the citizen participation process and municipal information gathering is hereby adopted; and

BE IT FURTHER RESOLVED, that the Mayor of the City of DuBois is empowered to place his signature, on behalf of the governing body, on the necessary application forms and affix thereto the official seal of the City of DuBois.

- (1) Publicizing the name and contact information of the local Fair Housing Officer, which will include the process to file a complaint if a person feels they have been discriminated against in housing in any manner and other applicable fair housing information through local media and community contracts; and

 (2) Conduct at least one fair housing activity annually to better inform the public of their rights under
 the Pair Housing Law and Pennsylvania Human Relations Act; and
 (3) Use the fair housing logo on all materials dealing with housing programs such as but not limited to:
 a. Public advertisements for vacancy or discussing the program
 b. Applications for assistance

AUTHORIZING THE ADOPTION OF SUFFICIENT SEWER RATES AND PROVIDING FOR THE IMPLEMENTATION THEREOF NO LATER THAN THREE MONTHS BEFORE THE SCHEDULED AMORTIZATION DATE AS DEFINED AT SETTLEMENT ON THE CITY'S \$88,317,000.00 MAXIMUM PRINCIPAL AMOUNT FUNDING ARRANGEMENT WITH THE PENNSYLVANIA INFRASTRUCTURE INVESTMENT AUTHORITY (LOAN ME NO. 75388).

WHEREAS, the City of DuBois, Clearfield County (the "City"), created and existing under the laws of the Commonwealth of Pennsylvania, has determined that it is necessary and in the best interests of the City to undertake a capital project to improve the wastewater system facilities (the "System") that are managed by the City, consisting of the rehabilitation of aging infrastructure and the construction of a new Sequencing Batch Reactor wastewater treatment facility.

WHEREAS, in order to finance the cost of the Project, the City intends to secure financing from the Pennsylvania Infrastructure Investment Authority in the maximum principal amount of \$88,317,000.00 to be evidenced by a debt obligation (the "Debt Obligation"); and

WHEREAS, the City desires to adopt this Resolution to evidence its intent to adopt residential rates for the System that, will produce revenues sufficient to cover all of its operational and maintenance costs and the debt service on the Debt Obligation.

NOW, THEREFORE, BE IT RESOLVED, that the rate is \$19.00 per thousand gallons each month, implemented by the City, to be effective July 1, 2025, to produce revenues from the operation of the System sufficient to cover all operational and maintenance costs and the debt service on the Debt Obligation.

The motion was made by Dietz and seconded by Gabriel that Council approve the revised Resolution No. 2022-0352 – PennVEST Rate Resolution as presented. Councilwoman Bernardo had a question on the vote: She asked Nasuti if he can guarantee that that person he talked to will be there if we need to change the rate in the future or do we have anything in writing? Nasuti stated he can't guarantee the person will be there, the same as he can't guarantee the rate will be \$19. If

we get to July 2025 and our costs increase and \$20 will cover costs, we will set an ordinance with the amount at \$20. Solicitor Cherry stated what the lawyers for PennVEST are most concerned about is whether or not that is going to be a sufficient amount to payoff that debt. If we want to reduce it because somehow we come into a windfall, their position is it's not going to go below that because that's the rate that has been calculated to ensure that their debt is paid. Their goal is to make sure we can meet our obligation to pay back this loan. Roll call vote was as follows: Bernardo, yea; Aughenbaugh, yea; Gabriel, yea; Dietz, yea; Walsh, yea. Motion passed 5-0.

Chris Nasuti – City Engineer/Public Works Director

Met with Hawbaker's today, everything is on track. Putting a base coat on Maple Avenue by the end of October. Working on Hospital Avenue, Munro and Arminta the week of the 17th. Then back to pave Maple and Chestnut Avenue. Everything should be concluded the first week in November.
