City Council Meeting Minutes - October 23, 2023

City Council Chambers, City Building, 16 West Scribner Avenue, DuBois, Pennsylvania on Monday, October 9, 2023, at 6 p.m.; Council convened at their regular City Council Meeting with Mayor Walsh in the Chair. Other Council Members present were James Aughenbaugh, Shane Dietz, and Pat Reasinger. Also present were City Solicitor, Toni Cherry; Police Chief, Blaine Clark; Public Works Superintendent, Scott Farrell; Tax Collector, Lisa LaBrasca Becker; Code Enforcement/Zoning Officer, Zac Lawhead; Finance Officer, DeLean Shepherd; and City Controller, David Volpe.

Absent: Councilman Diane Bernardo.

The meeting was called to order at 6 p.m. and the Pledge of Allegiance was led by Mayor Walsh.

Additions to Agenda

Mayor Walsh called for a motion to excuse Councilwoman Diane Bernardo from the meeting. The motion was made by Aughenbaugh and seconded by Reasinger to excuse Bernardo. Roll call as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, yea; Walsh, yea. Motion passed 4-0.

Mayor Walsh stated we have an agenda item addition so Solicitor Cherry can read a deed that we need to vote on. The motion was made by Reasinger and seconded by Dietz to add the item to the agenda. Roll call was as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, yea; Walsh, yea. Motion passed 4-0.

Miss Cherry explained the Redevelopment Authority of the City of DuBois has approved the sale of property to CO.3, LLC to repair and develop the building (which formerly housed Tommy D's). The Redevelopment Authority believes the transaction will be valuable to the City. Attorney Paula Cherry and Attorney Chris Mohney together have reviewed these matters, and an agreement of sale and contract has been prepared and signed by the prospective buyers. Cherry recommends Council approve the sale that has been agreed upon by the Redevelopment Authority stating that it meets all the City's requirements. Once the City approves it, Mayor Walsh will sign it and turn it over to the Redevelopment Authority to proceed with the sale.

The motion was made by Reasinger and seconded by Dietz to approve the transfer of deed. Roll call was as follows: Aughenbaugh, yea; Reasinger, yea; Walsh, yea. Motion passed 4-0.

Approval of Minutes

City Council Meeting Minutes - October 9, 2023

The motion was made by Aughenbaugh and seconded by Reasinger that Council approve the City Council Meeting Minutes of October 9, 2023, as presented. Roll call was as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, abstain; Walsh, yea. Motion passed 3-0.

Registry of Invoices

The motion was made by Dietz and seconded by Aughenbaugh that Council approve the Auto Draft Check Register by Check ID dated October 19, 2023, in the amount of \$16,582.19; the General Fund Purchase Order Listing by Vendor Name dated October 19, 2023, in the amount of \$422,050.89; and the Pennvest Check Register by Check ID List in the amount of \$2,626,432.26. The motion was made by Dietz and seconded by Aughenbaugh to approve the Registry of Invoices as presented. Roll call as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, yea; Walsh, yea. Motion passed 4-0.

Public Comments

Shirley Dahrough - Downtown DuBois, Inc.

Advocating for downtown, Shirley asked Council to not sell the Scribner lot and provided signatures of support from several business owners. They believe the property is an asset to our community and the space will be needed after the merger (with Sandy Township). Councilman Reasinger agreed and asked Tom Nowak to share his idea for the property. Nowak feels the building on the property would be an asset to the city because it can house the Treasurer's Office and be used as a drive-thru for residents to come and pay their taxes and utility bills and have some parking. Shirley supports the idea saying it is 'fabulous' and will benefit the elderly and handicapped who cannot easily access the City building.

Lisa LaBrasca Becker thinks it will be a great idea for the citizens of our community because there are people who do have trouble getting in our doors. It also will be more convenient for residents. She also added that there is a safe in-house and maybe she will be able to have an office of her own. She thanked Council for considering this idea.

Mayor Walsh stated the reason we did this is we had someone approach us to buy the property and build on it. Council had to put it out for bids. We have the right to accept or reject all bids.

Steve Way agreed it is a great idea. "We are always constantly trying to engage with people in our community and tourists coming into the area. Don't sell the assets when there are other buildings and property that private entities want to add or develop the downtown area.

Clearfield County Commissioner, Dave Glass, who has had several business owners approach him, said, "I understand sometimes we don't always have all the facts. It kind of seems this has been hurried. If there is a good solid reason that we need to communicate better so they understand it. Maybe have more of a round-table discussion about their concerns and make sure the positives outweigh the negatives. Again, I don't know what you guys are looking at either. I don't think there should be any hurry for it."

Councilman Aughenbaugh agreed he felt it was rushed. "That is why it was tabled. To get more information and get a chance to hear from more people. I thought it was too quick myself so that's why I asked for it to be tabled at the last meeting."

Sandy Township Supervisor, Mark Sullivan renewed his objections to the sale of the West Scribner lot until after consolidation to be sure additional parking is not needed for staff at the municipal building.

Don Neubert - Randall Court

Don said there is a lot of traffic – 3,4 and 5 vehicles - running red lights in the community making these intersections unsafe. He asked if we could get traffic cameras that can be used to ticket offenders. Mayor Walsh said we have looked into it. It is illegal in Pennsylvania to use cameras to issue tickets. They are used more for information like when there is a vehicle accident. Walsh asked Chief Clark to speak more on the subject. Chief Clark confirmed that it is illegal to use cameras for law enforcement. It is only allowed in Philadelphia and Pittsburgh. Aughenbaugh added that cameras could be used at intersections to activate traffic lights so people aren't sitting at a red light when there is no traffic. There is one by the Sheetz on Brady Street. We are looking to add more but they are quite expensive.

Crime Stoppers – Jeremy Ruffner

Jeremy who is 911 Coordinator of Clearfield County and sits on the board of Crime Stoppers, gave a presentation. The District Attorney has provided drug forfeiture money to purchase signs. He distributed samples of the signs. Jeremy is here to talk about Crime Stoppers and get Council's blessing to put up signs around DuBois, and to make everyone aware there is another avenue to report crime. People want to be part of the solution but remain anonymous. Anonymous reports lead to a lot of arrests. Anyone who wants to participate can join us. We are always looking for new members.

Mayor Walsh asked Chief Farrell if this is something our guys do or does Crime Stoppers install them? Farrell replied, "Either way." Jeremy explained that Crime Stoppers provides the signs and bolts to install them. They are numbered and labeled so we know where they are located. The signs can be moved around if there is an area of town where there is a problem, they will move them. When the calls come in, there is no caller ID, no name asked. They just take the information about the crime and pass it on.

Mayor Walsh asked if Crime Stoppers would be willing to meet with the City to determine the best locations for the signs. Jeremy said they would.

If businesses want to get involved, signs will be available to put inside businesses. He gave his contact information to all Council members. When asked if the signs will have lighting on them, Jeremy said they are open to suggestions. We are a small committee right now and are just re-launching this.

The motion was made by Aughenbaugh and seconded by Dietz to approve Crime Stoppers putting up signs in the City of DuBois. Roll call was as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, yea; Walsh, yea. Motion passed 4-0.

Proposals to purchase the West Scribner Avenue Parking Lot

The motion was made by Reasinger and seconded by Aughenbaugh to reject all bids. Roll call was as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, yea, Walsh, yea. Motion passed 4-o.

There was a round of applause from the audience.

2023 Park Improvements

DeLean shared the recommendation from Chris Nasuti to table the park improvements until after the forensic audit has been completed before committing the city to additional debt. The motion was made by Reasinger and seconded by Dietz to accept the recommendation to table the matter until after the audit. Roll call was as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, yea; Walsh, yea. Motion passed 4-0. Motion passed 4-0.

The audience again responded with a round of applause.

Aughenbaugh mentioned that there is the grant, and we still have time with that.

Award Dam Evaluations to HRG

- a. Juniata Lake \$15,000 b. Anderson Creek \$211,000

DeLean explained the PA Department of Environmental Protection (PADEP) inspected two dams in the area and found deficiencies. We need to do studies to figure out what we want to do with them and how we're going to pay for it. Aughenbaugh explained that the DEP mandated this. They changed the requirement back in 2009. He stressed this is to evaluate the dams. Mayor Walsh said the two awards will be handled individually.

The motion was made by Reasinger and seconded by Dietz to award the dam evaluation at Juniata Lake in the amount of \$15,000 to HRG. Roll call was as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, yea; Walsh, yea. Motion passed 4-0.

The motion was made by Aughenbaugh and seconded by Dietz to award the dam evaluation at Anderson Creek (better known as the DuBois Reservoir) in the amount of \$211,000 to HRG. Roll call was as follows: Aughenbaugh, yea; Reasinger, yea; Dietz, yea; Walsh, unfortunately yea. Motion passed 4-0.
