

**COUNCIL BILL NO. 1717, SECOND AMENDMENT**

**ORDINANCE NO. 1628**

**AN ORDINANCE**

**AMENDING CHAPTER 18, PART 3 OF THE CODE OF ORDINANCES OF THE CITY OF DUBOIS TO PROVIDE FOR THE IMPOSITION OF A FEE FOR COMPLIANCE MONITORING, INSPECTIONS AND SURVEILLANCE PROCEDURES AND TO IMPOSE AN OIL AND GREASE SURCHARGE RATE FOR INDUSTRIAL WASTE HAVING AN OIL AND GREASE CONCENTRATION IN EXCESS OF 300 MILLIGRAMS PER LITER.**

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by the Council of the City of DuBois, in Council assembled, and it is hereby enacted and ordained by authority of the same, as follows:

**Section 1.** Chapter 18, Part 3, Section 303.1.C.(13) shall be amended to read as follows:

Any waste water containing petroleum oil, nonbiodegradable cutting oil or products of mineral oil origin in amounts that will cause interference or pass through or waste water containing more than three hundred (300) mg/L of fat, oil or grease (Freon extractables) of animal or vegetable origin.

**Section 2.** Chapter 18, Part 3, Section 305.02(b) shall be amended to read as follows:

A fee of \$400.00 per month shall be imposed against any person discharging such abnormal industrial waste into the public sanitary sewerage system as that term is defined in other parts of this Ordinance for the purposes of compliance monitoring, inspections and surveillance procedures.

**Section 3.** Chapter 18, Part 3, Section 305.02(c) shall be amended to add the following:

A fee of \$100.00 per incident shall be charged to any individual discharging abnormal industrial waste into the public sanitary sewerage system for reviewing accidental discharge procedures and construction.

**Section 4.** Chapter 18, Part 3, Section 306 shall be amended to add Subsection 6 as follows:

The surcharges provided for in this Article shall be added to the regular sewerage service charge and any other industrial user charges imposed by the City under the prevailing sewer rate of this Ordinance. The surcharges shall be due at the same time and subject to the same late payment penalties and delinquency remedies established by the City for regular sewerage service charges.

**Section 5.** All other portions of Chapter 18 of the Code of Ordinances of the City of DuBois not in conflict herewith are hereby re-ratified and reaffirmed as if set forth at length herein.
