ORDINANCE NO. 1657

AN ORDINANCE OF THE CITY OF DUBOIS AMENDING CHAPTER 21 OF THE CODE OF ORDINANCES OF THE CITY OF DUBOIS BY ADDING PART 15, SECTIONS 1502 AND 1503 VACATING TWO 16-FOOT UNOPENED ALLEYS RUNNING IN A NORTHEASTERLY DIRECTION FROM THE EASTERN BOUNDARY LINE OF RUMBARGER AVENUE IN WHITTLE'S ADDITION TO THE CITY OF DUBOIS IN THE FIFTH WARD OF THE CITY OF DUBOIS.

BE IT ORDAINED by the Council of the City of DuBois in Council assembled:

Section 1. That the unnamed 16-foot alley located in Whittle's Addition to the City of DuBois and shown on the City of DuBois Assessment Map in Section 21, situate in the Fifth Ward of the City of DuBois and extending from the easterly right-of-way line of Rumbarger Avenue, between Lots 6745 and 6746, having never been opened, is hereby declared vacated. Said unopened, unnamed alley is described as follows:

BEGINNING at a point at the intersection of the eastern right-of-way line of Rumbarger Avenue and the southwestern right-of-way line of the 16-foot unopened alley; said point also being the southeastern corner of Lot 6745 in Whittle's Addition to the City of DuBois; thence in a northeastern direction along the westerly line of the right-of-way of said unopened alley and the eastern boundary line of Lot 6745 to the southern boundary line of Lot 6722; thence in a southeasterly direction 23.3 feet, more or less, to the end of the right-of-way for Marshall Alley; thence in a southwesterly direction 8 feet, more or less, to the northern boundary line of Lot 6746 in the Whittle's Addition to the City of DuBois; thence in a northwesterly direction to a point at the intersection of the northwestern corner of Lot 6746 and the eastern boundary line of the right-of-way for the 16-foot alley; thence along the westerly line of Lot 6746 and the easterly line of the right-of-way for the unopened 16-foot alley to the intersection of the southwestern corner of Lot 6746 and the easterly line of the right-of-way for Rumbarger Avenue; thence in a northwesterly direction along the easterly line of Rumbarger Avenue to the westerly right-of-way line of the unopened 16-foot alley and the place of beginning.

Section 2. That the unnamed 16-foot alley located between Lots 6750 and 6751 in the Whittle's Addition to the City of DuBois and shown on the City of DuBois Assessment Map in Section 21, situate in the Fifth Ward of the City of DuBois and extending from the easterly right-of-way line of Rumbarger Avenue to the westerly line of the 16-foot right-of-way of Marshall Alley, having never been opened, is hereby declared vacated. Said unopened, unnamed alley is described as follows:

BEGINNING at a point at the intersection of the eastern right-of-way line of the right-of-way of Rumbarger Avenue and the southeastern corner of Lot 6750; thence along the easterly boundary line of Lot 6750 along the westerly right-of-way line of the 16-foot unopened alley, a distance of 180 feet, more or less, to the southerly right-of-way line of the right-of-way for Marshall Alley; thence in a southeasterly direction along the westerly right-of-way line of Marshall Alley 16-feet, more or less, to a point at the northwestern corner of Lot 6751; thence along the boundary line of the westerly line of Lot 6751 and the easterly line of the 16-foot right-of-way for the unopened, unnamed alley, a distance of 180 feet, more or less, to the easterly right-of-way line of Rumbarger

Avenue; thence along the easterly line of the right-of-way for Rumbarger Avenue a distance of 16 feet, more or less, to the place of beginning.
