ORDINANCE NO. 1664

AN ORDINANCE

AMENDING CHAPTER 15 OF THE CODE OF ORDINANCES OF THE CITY OF DUBOIS TO AMEND THE AMOUNT OF FINES IMPOSED FOR PARKING VIOLATIONS COMMITTED WITHIN THE CITY OF DUBOIS.

BE IT ORDAINED AND ENACTED by the Council of the City of DuBois assembled, and it is hereby enacted and ordained by authority of the same that Chapter 15 of the Code of Ordinances of the City of DuBois shall be amended as follows:

Section 1. On and after the passage of this Ordinance, the fines and penalties for those persons, firms or corporations whose parking meter time has expired or who neglect to put money in the meter shall be as follows:

 (a) \$5.00, if paid at the Police Department Office within twenty-four (24) hours of the time of the violation;

(b) \$10.00, if paid after forty-eight (48) hours and before seventy-two (72) hours:

(c) If the ticket is unpaid after seventy-two (72) hours from time of violation, a citation will be issued and \$15.00 and costs will be added to the fine set forth on the ticket upon conviction thereof.

Section 2. On or after the passage of this Ordinance, the fines and penalties for those persons, firms or corporations who shall violate any of the parking time limitations as set forth by proper signs on the said streets, avenues, alleys, and parking lots owned by the City of DuBois that are not metered shall be as follows:

 (a) \$5.00, if paid at the Police Department Office within twenty-four (24) hours of the time of the violation;

(b) \$10.00, if paid after the above-stated time of twenty-four (24) hours and before seventy-two (72) hours;

(c) If the ticket remains unpaid after seventy-two (72) hours from time of violation, a citation will be issued and, upon conviction thereof, a fine of \$15.00 and costs will be added to the fine set forth on the ticket.

Section 3. On and after the passage of this Ordinance, the fines and penalties for those persons, firms or corporations who have parked in a prohibited area; or too close to the corner; or in an area where parking is prohibited from 7:00 a.m. to 11:00 a.m.; or in an area where parking for more than fifteen (15) hours is prohibited; in an area where parking is prohibited from 2:00 a.m. to 7:00 a.m.; in an area too close to a fire hydrant or in a private lot or in the wrong direction, the fine and penalty shall be as follows:

 (a) \$15.00 if paid at the Police Department Office within twenty-four (24) hours of the time of the violation;

(b) If unpaid for after twenty-four (24) hours from time of violation, a citation will be issued and \$15.00 and costs will be added to the ticketed fine upon conviction thereof. Section 4. Any portion of this Ordinance in conflict with the penalties imposed by the Pennsylvania Vehicle Code shall be deemed to be superseded by the provisions of that Code.

Section 5. The within Ordinance shall be effective upon final enactment hereof.

Section 6. All other ordinances or parts of ordinances in conflict herewith be and the same are herewith repealed.
