ORDINANCE NO. 1705

AN ORDINANCE

OF THE CITY OF DUBOIS AMENDING CHAPTER 26, PART I, SECTION 183 OF THE CODE OF ORDINANCES OF THE CITY OF DUBOIS ENTITLED "NOTICE TO MAKE CONNECTION" TO ELIMINATE ANY EXCEPTION TO THE REQUIREMENT THAT AN OWNER OF ANY IMPROVED PROPERTY ABUTTING UPON THE WATER SYSTEM OF THE CITY OF DUBOIS SHALL CONNECT SUCH IMPROVED PROPERTY AND AMENDING CHAPTER 26, PART I, SECTION 184 ESTABLISHING PROCEDURES FOR NOTICE TO MAKE CONNECTION TO SHORTEN THE TIME IN WHICH CONNECTION SHALL BE MADE AFTER NOTICE.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the City of DuBois, in Council assembled, and it is hereby enacted and ordained by authority of the same, as follows:

**Section 1.** Chapter 26, Part I, § 183 of the Code of Ordinances of the City of DuBois is hereby amended to read as follows:

§183. Notice to Make Connection. The owner of any improved property abutting upon the water system, shall connect such improved property with and shall use the water system owned and operated by the City of DuBois and/or the Water Bureau of the City of DuBois in such manner as the City of DuBois or the Water Bureau may require, within thirty (3) days after notice to such owner from either the City of DuBois or the DuBois Water Bureau to make such connection; subject to such limitations and restrictions as shall be established herein or otherwise shall be established by either the City of DuBois, or the DuBois Water Bureau or both.

**Section 2.** Chapter 26, Part I, §184 of the Code of Ordinances of the City of DuBois shall be amended and revised to read as follows:

§184. Procedures for Notice to Make Connection. The notice by the City of DuBois or the DuBois Water Bureau to make connection to a main referred to in this Chapter shall consist of a copy of this Part, including any amendments and/or supplements at the time in effect, or a summary of each Section thereof, any written or printed document requiring the connection in accordance with the provisions of this Part and specifying that such connection shall be made within thirty (3) days after the date such notice is given or served. Such notice may be given or served at any time after a main is in place which can deliver water to the particular improved property. Such notice shall be given or served upon the owner in accordance with law.

**Section 3.** All other portions of Chapter 26, Part I are hereby reaffirmed and re-ratified insofar as the same are not in conflict herewith.

**Section 4.** All other Ordinances or parts of Ordinances or Resolutions in conflict herewith be and the same are herewith repealed.

**Section 5.** The within Ordinance shall be effective upon final enactment hereof.
