ORDINANCE NO. 1835

AN ORDINANCE

OF THE CITY OF DUBOIS AMENDING CHAPTER 15, PART III, SECTION 304 OF THE CODE OF ORDINANCES OF THE CITY OF DUBOIS TO ADD THAT TRUCK TRAFFIC ON MAIN STREET BETWEEN DUBOIS STREET AND DIXON AVENUE AND ON DUBOIS STREET BETWEEN DUBOIS AVENUE AND MAIN STREET OTHER THAN LOCAL TRAFFIC SHALL BE PROHIBITED AND TO INCREASE THE PENALTY FOR VIOLATION OF ANY PROHIBITION OF TRUCK TRAFFIC ON CERTAIN STREETS TO A FINE OF UP TO \$500.00 UPON CONVICTION THEREOF.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the City of DuBois, in Council assembled, and it is hereby enacted and ordained by authority of the same, as follows:

**Section 1.** Chapter 15, Part III, Section 304 entitled "Truck Traffic Restricted on Certain Streets" that sets forth the streets where it shall be unlawful for any person to drive a vehicle other than a passenger car shall be amended to add the following:

<u>Street</u>	<u>Between</u>
Main Street	DuBois Street and Dixon Avenue
DuBois Street	DuBois Avenue and Main Street

**Section 2.** All other portions of Chapter 15, Part III under paragraph 1. reading as follows are hereby reaffirmed and re-ratified insofar as the same is not in conflict herewith:

Provided, nothing in this Section shall prohibit any person from driving an emergency vehicle on any of those streets or parts of streets, or from driving on any of those streets or parts of streets a truck or other commercial vehicle making local deliveries to or pickups from premises located along that street or part of a street.


**Section 3.** Chapter 15, Part III, Section 304.2. is hereby amended to increase the fine for a violation of any provision of Section 304, upon conviction, from the prior amount of \$25.00 plus costs to a new fine of up to \$500.00 plus costs.

**Section 4.** All other portions of Chapter 15, Part III are hereby reaffirmed and re-ratified insofar as the same are not in conflict herewith.

**Section 5.** All other Ordinances or parts of Ordinances or Resolutions in conflict herewith be and the same are herewith repealed.

**Section 6.** The within Ordinance shall become effective upon final enactment hereof.
