ORDINANCE NO. 1850

AN ORDINANCE

AMENDING CHAPTER 340 OF THE CODE OF ORDINANCES OF THE CITY OF DUBOIS TO AMEND THE SURCHARGE RATE TO BE ADDED TO EVERY MONTHLY BILL FOR EVERY CUSTOMER OF THE CITY'S SEWER SYSTEM TO ALLOW RECOVERY OF THE PRINCIPAL AND INTEREST PAYMENTS OWING ON LOANS SECURED TO COMPLETE CONSTRUCTION PROJECTS FOR THE REPAIR AND/OR REPLACEMENT OF THE SEWER SYSTEM OF THE CITY OF DUBOIS.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the City of DuBois, in Council assembled, and it is hereby enacted and ordained by authority of the same, as follows:

SECTION 1. That the following provision of Chapter 340-3.E. is hereby amended to read as follows:

Section 340-3.E. Surcharge Rates.

The surcharge rates shall be as follows:

<u>Size of Water Meter</u>	<u>Rate</u>
5/8 – 3/4" water meter	\$ 5.00
1" water meter	\$ 7.50
1.5" water meter	\$ 22.00
2" water meter	\$ 34.50
3" water meter	\$ 56.50
4" water meter	\$109.50
6" water meter	\$141.00
8" water meter	\$187.50

SECTION 2. Nothing herein shall alter, change, amend or otherwise affect any other sections of Chapter 340 of the Code of Ordinances, as previously amended, and all other provisions of Chapter 340, as previously amended, not in conflict herewith, are hereby reaffirmed and re-ratified as if set forth at length herein.

SECTION 3. All ordinances or parts of ordinances or resolutions in conflict herewith be and the same are herewith repealed.


SECTION 4. It is hereby declared to be the intention of City Council that the parts, sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable. If any section, paragraph, sentence, clause or phrase of this Ordinance is declared unconstitutional, illegal or otherwise invalid by the judgment or decree of a court of competent jurisdiction, that invalidity shall not affect any of the remaining parts, sections, paragraphs, sentences, clauses or phrases of this Ordinance.

SECTION 5. This Ordinance shall become effective immediately after passage and the surcharge rates enacted herein shall be imposed on all bills due for months beginning with the first month after passage of this Ordinance, and shall continue in effect until altered or changed by ordinance.
