Dear Ms. Shepherd,

This office represents the City of DuBois. This letter is a formal written response to the Right to Know Request ("request") you submitted to the City of DuBois dated August 2, 2024. Please note that, in addition to the following written response to the request, an Affidavit executed by Shawn Arbaugh, City Manager for the City of DuBois, is attached hereto, incorporated into this written response, made a part of this written response, and designated Exhibit A.

The request identifies and seeks access to six (6) separate records – 1) Treasurer's Cash Report as of 07/31/2024 on all funds ("record 1"); 2) July 2024 General ledger detail reports GF.100.010 through GF.299.999 including beginning and ending balances ("alleged record 2"); 3) July 2024 General ledger detail reports SF.100.010 through SF 299.999 including beginning and ending balances ("alleged record 3"); 4) July 2024 General ledger detail reports WF.100.010 through WF 299.999 including beginning and ending balances ("alleged record 4"); 5) Water Fund, Sewer Fund, General Fund Budget reports as of 07/31/2024 ("record 5"); and 6) May 2024 General ledger detail reports LF.100.010 through LF 299.999 including beginning and ending balances ("alleged record 6").

Regarding record 1, the request is granted, and a true and correct duplicate of the same is being provided to you along with this response.

As to alleged records 2, 3, 4, and 6 – all of which are identified as "General ledger detail reports" – the request is denied, as said alleged records do not *currently* exist and

were not in existence as of the date on which the request was submitted. Therefore, said alleged records are not in the possession of the City of DuBois.

65 P.S. § 67.705, provides that, "[w]hen responding to a request for access, an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner in which the agency does not currently compile, maintain, format or organize the record". "Under Section 705 of the RTKL[,] . . . the standard is whether such a record is in existence and in possession of the Commonwealth agency at the time of the right-to-know request". Saunders v. Dep't of Corr., 172 A.3d 110, 112 (Pa. Commw. 2017). As in Saunders, the City of DuBois has supplemented this response with an affidavit signed by Shawn Arbaugh, City Manager for the City of DuBois, which states and verifies that the City of DuBois is not in possession of the requested records and records do not currently exist and did not exist as of the date of the request. Mr. Arbaugh's affidavit verifying the non-existence of alleged records 2, 3, 4, and 6 are "enough to satisfy the [City of DuBois'] burden of demonstrating the nonexistence of the record[s] requested, and obviously the [City of DuBois] cannot grant access to a record that does not exist". Id. at 113. Because the City of DuBois cannot be compelled to produce a record that does not exist, the request for alleged records 2, 3, 4, and 6 is denied.

Regarding record 5 – "Water Fund, Sewer Fund, General Fund Budget reports as of 07/31/2024" – these records are exempt from access pursuant to 65 P.S. § 67.708(b)(12).

Section 708(b)(12) of the RTK Law exempts from access "[n]otes and working papers prepared by or for a public official or agency employee used solely for that official's or employee's own personal use, including . . . materials that do not have an official purpose". "'Personal' within the foregoing definition does not mean that it has to involve a public official's personal affairs[.] . . . it covers those documents necessary for that official that are 'personal' to that official in carrying out his [or her] public responsibilities". City of Philadelphia v. Phila. Inquirer, 52 A.3d 456, 461 (Pa. Commw. 2012). In affirming the Court of Common Pleas' decision in City of Philadelphia v. Phila. Inquirer, (2011 Phila. Ct. Com. Pl. Lexis 192), the Commonwealth Court cited Bureau of Nat'l Affairs, Inc. v. United States DOJ, 742 F.2d 1484 (D.C. Cir. 1984), a case involving a request under the Federal Freedom of Information Act, as persuasive authority offering interpretive guidance under the RTK Law's notes-and-working-papers exception. Bureau of Nat'l Affairs addressed and distinguished officials' daily agendas, which were created for the express purpose of facilitating daily activities of a division, from appointment calendars retained solely for the convenience of individual officials and were not generally circulated. Bureau of Nat'l Affairs stands for the legal proposition that, with respect to the RTK Law's notes-and-working-papers exception, a record falls under this exception if

it was created 1) solely for the convenience of the City of DuBois' elected public officials; and 2) not circulated outside the public officials' offices.

Here, as evidenced and verified in the attached affidavit of Shawn Arbaugh, City Manager for the City of DuBois, record 5 was created specifically and solely for the convenience of City Council members; was not circulated beyond or outside City Council members' offices; and was not used for any official purpose. "The RTKL expressly requires that informal 'working papers' be 'used solely for that official's . . . own personal use'. This plain language means that 'working papers' are used by the official alone". *City of Philadelphia*, 52 A.3d at 463. Therefore, the "Water Fund, Sewer Fund, General Fund Budget reports as of 07/31/2024" are exempt from access under 65 P.S. § 67.708(b)(12), and, consequently, the request for the same is denied.

I hereby swear and affirm under penalty of perjury that the record requested by Requester identified as "Water Fund, Sewer Fund, General Fund Budget reports as of 07/31/2024" was created specifically and only for the convenience of City Council members; was not circulated beyond or outside City Council members' individual offices; and was not used for any official purposes. was only distributed to City Council members for their own personal use, the document was not provided or disclosed to any employees of the City of DuBois.
