On July 18, 2024, you requested employment termination letters for Mr. Clark and Mr. Suplizio.

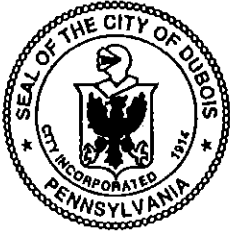

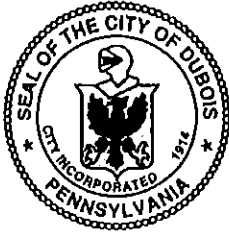
