

Thank you for writing the City of DuBois with your request for information pursuant to the Pennsylvania Right-To-Know law.

On September 10, 2024, you submitted right-to-know requests asking questions regarding what business was discussed in private meetings with the manager, and who Bob Bojalad went to see at the public works garage and what he discussed. The request did not seek any specific documents and therefore is denied under the right-to-know law.

You have a right to appeal this in writing to: Office of Open Records, 333 Market St., 16th Floor, Harrisburg, PA 17101-2234. Appeals can also be filed online at the Office of Open Records website, <a href="https://www.openrecords.pa.gov">https://www.openrecords.pa.gov</a>.

If you choose to file an appeal you must do so within 15 business days of the mailing date of the agency's response. See 65 P.S. § 67.1101. Please note that a copy of your original Right-to-Know request and this denial letter must be included when filing an appeal.
