Solar System Project Presentation and Request

Officer Casey Doherty has been working with a group from the DuBois Area High School on a proposed project. Four of the members, accompanied by their advisor, gave a presentation proposing a scaled Solar System model to be located in City Park and along the Beaver Meadow trail. The model, with a path 1.97 miles long, will be educational as it shows distance between the planets which will be made from textured cast steel encouraging touch and feel, and each planet will have a plaque with a QR code to a website with virtual guided tours and additional information. Doherty had seen a similar model in Washington, D.C. and there is one located on Route 153 going to Clearfield. The students believe having a model in DuBois will draw interest to the community. When asked about budget, Doherty estimated \$50,000.00 including the posts, models and informational signage. The City's IT Director feels confident he can integrate the students' information from the QR codes onto the City's website. As for project timeline, Doherty would like to see it completed in these students' school year, but he and the advisor are open to doing the work in phases to include additional students.

The motion was made by Jackson and seconded by Aughenbaugh to give approval to the students to proceed with the Solar System model project and offered the City's assistance, as needed. Green Light Go - Authorization to Advertise for Proposals

This is to advertise for design of the traffic signal at Beaver Drive and Liberty Boulevard. We received \$310,040.00 for modernization of the signal and equipment. We do have a 20% match. Aggregate Materials - Authorization to Advertise for Bids

We are looking for approval to advertise for 1,000 tons of 1B; 5,000 tons of 2A; 1,000 tons of Type A sand; and 1,000 tons of anti-skid. Aughenbaugh asked if this will be done in conjunction with Sandy Township; Arbaugh confirmed. The motion was made by Aughenbaugh and seconded by Jackson to approve advertising for bids for the above-mentioned aggregate materials. Pension Advisor – Award Professional Services Proposal for Uniform and Non-Uniform Pension Plans Council received seven responses to our RFP for services. The pension committee conducted a series of interviews, and the recommendation is to award the pension management contract to C. S. McKee. The firm has had great returns over the past 10 years, a reasonable fee structure, numerous municipal government clients that are Third Class cities, and a conservative investment strategy. They are the only GIPS certified firm (gold standard in pension) who responded to the RFP. The motion was made by Jackson and seconded by Gelfand to award the professional services for both the Uniform and Non-Uniform Pension Plans to C. S. McKee. As Council is talking about an Economic Developer to help promote the City, Watt encouraged Council to consider engaging with an urban planning company – if one exists – to lay out a plan to help the City survive and thrive. He sees an Economic Developer as a salesman and a planning company as an engineer.

<u>Katelynn McClure – Jared Street</u>

McClure asked if a market study or a market analysis have been done on what will happen to property and real estate values when the consolidation takes place. Arbaugh said there have not.

Council Member Comments

Mayor Pat Reasinger

"You may have noticed barriers on Long Avenue. There is a weakness in the bridge, and the State gave us the option to either close the bridge or reduce the weight on the bridge. It may be inconvenient, but the priority is the public's safety until repair work can be done." Arbaugh noted the work will go out for bid in January with the work to be done in the Spring.

City Manager Shawn Arbaugh

"I wanted to let the public know the traffic light at Brady and Park was struck today. We are working with PennDOT to make sure it is structurally sound. We're also working with the Police Department to catch the hit-and-run driver of the oversized load that caused the damage."
