Third Ward Firehall, 301 First Street, DuBois, Pennsylvania on Monday, December 23, 2024, at 6 p.m.; Council convened at their regular City Council Meeting with Mayor Pat Reasinger in the Chair. # Resolution No. 2024-0399 - Amusement Tax Fee

This resolution sets the fee consistent with the City ordinance for mechanical amusement devices. The fee effective January 1, 2025, will be \$500.00 per machine offered for public. This fee is for mechanical skill gaming machines only; it does not apply to pool tables, claw machines, etc. The motion was made by Gelfand and seconded by Jackson to approve Resolution No. 2024-0399 setting the annual fee for mechanical amusement devices at \$500.00 per machine effective January 1, 2025. Roll call was as follows: Dietz, yea; Aughenbaugh, yea; Jackson, yea; Gelfand, yea; Reasinger, yea. Motion passed 5-0.

# Resolution No. 2024-0398 – 2025 Meeting Schedule

This resolution sets the City Council and Consolidation Joint Board meeting schedule for 2025. Because of Consolidation, all decisions must be approved by the Consolidation Joint Board and ratified by the individual municipalities immediately following. Sandy Township Supervisors can drop down to one meeting a month; however, per City ordinance, DuBois must continue to hold two monthly meetings. One of those meetings will be a work session and/or regular meeting nine (9) days prior to the Consolidation Joint Board meeting. Some meetings will be on the first Monday of the month (April, July and October) while the remaining meetings will be on the second Monday. The motion was made by Aughenbaugh and seconded by Jackson to approve Resolution No. 2024-0398 setting the 2025 Meeting Schedule with the amendment the wording be changed to "work session and/or regular meeting". Roll call was as follows: Dietz, yea; Aughenbaugh, yea; Jackson, yea; Gelfand, yea; Reasinger, yea. Motion passed 5-0.

#### Personnel – Human Resources Position

The Co-Managers are requesting approval to create, post and fill a full-time exempt Human Resources Administrator position with a salary of up to \$70,000.00. This is a critical position going into consolidation because there will be approximately 90 employees; it will cover risk, safety and all the laws and policies involved with human resources – both union and non-uniform employees. The motion was made by Jackson and seconded by Gelfand to approve full-time Human Resources position as explained. Roll call was as follows: Dietz, yea; Aughenbaugh, yea; Jackson, yea; Gelfand, yea; Reasinger, yea. Motion passed 5-0.

# RESOLUTION NO. 2024-0398

# RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DUBOIS APPROVING THE PROGRAM MODIFICATION TO THE FY 2023 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

WHEREAS, the City of Dubois is a recipient of Community Development Block Grant (CDBG) funds through the Commonwealth of Pennsylvania under the State Act 179; and

**WHEREAS**, the Pennsylvania Department of Community and Economic Development (PA DCED) has provided a grant to the City of Dubois under the FY 2023 CDBG Program to address the housing, community and economic development needs in the City; and

**WHEREAS**, there is a need to reallocate a balance of funds to address the needs in the City; and

**WHEREAS**, the City's staff and Consultant have prepared a Program Modification which consists of the following:

# FY 2023 CDBG Program Year

- 1. Delete the Quarry Avenue and Robinson Street Waterline Improvements Project line item activity in the amount of \$253,134.00.
- 2. Add a new activity to fund a Waterline Improvements Project on portions of Orient Avenue, Division Street, North Court, and South Court in the amount of \$253,134.00.

**NOW, THERFORE BE IT RESOLVED,** that the City Council of the City of Dubois, hereby approves the proposed program modification to the FY 2023 CDBG Program Year and authorizes the filing of said modification with the PA Department of Community and Economic Development; and

BE IT FURTHER RESOLVED that the Mayor of the City of Dubois is authorized to execute all necessary documents on behalf of the City of Dubois in regard to the Pennsylvania Community Development Block Grant Program; and furthermore, is authorized and made responsible for performing the overall coordination and administration of the City's FY 2023 Community Development Block Grant Program.
