ORDINANCE NO. 1884AN ORDINANCE

AMENDING CHAPTER 340 OF THE CODE OF ORDINANCES OF THE CITY OF DUBOIS TO AMEND THE RATES FOR TREATMENT OF SANITARY SEWAGE.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the City of DuBois, in Council assembled, and it is hereby enacted and ordained by authority of the same, as follows:

SECTION 1. That the following provision of Chapter 340-3.A. is hereby amended to read as follows:

Section 340-3A. Rates for Treatment of Sanitary Sewage

1. All persons owning property within the boundary lines of the City of DuBois and connecting to the sewer system shall pay the City a monthly rental for sanitary sewage service based on the quantity of water used as evidenced by meter readings of water meters installed for the purpose of measuring water purchased from and furnished by the Water Works and such other meters as may be installed pursuant to any provisions of the Code of Ordinances of the City of DuBois. The amount of such rental shall be the sum of \$17.00 per 1,000 gallons of water per month or portion thereof.

SECTION 2. That the following provision of Chapter 340-3.D. is hereby amended to read as follows:

Section 340-3D. Rates for Treatment of Sanitary Sewage

4. The foregoing language of Section 340 notwithstanding, the rate charged to all industries and manufacturing companies located within the corporate boundaries of the City of DuBois shall be billed on a monthly basis at the following rates:

<u>Monthly Usage</u>	<u>Rate Per 1,000 Gallons</u>
1 to 400,000 gallons	\$ 17.00
400,001 to 800,000 gallons	\$ 7.19
800,001 to 1,200,000 gallons	\$ 4.73
Any usage over 1,200,000 gallons per month	\$ 3.22

SECTION 3. Nothing herein shall alter, change, amend or otherwise affect any other sections of Chapter 340 of the Code of Ordinances, as previously amended, and all other provisions of Chapter 340, as previously amended, not in conflict herewith, are hereby reaffirmed and re-ratified as if set forth at length herein.

SECTION 4. All ordinances or parts of ordinances or resolutions in conflict herewith be and the same are herewith repealed.

SECTION 5. It is hereby declared to be the intention of City Council that the parts, sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable. If any section, paragraph, sentence, clause or phrase of this Ordinance is declared unconstitutional, illegal or otherwise invalid by the judgment or decree of a court of competent jurisdiction, that invalidity shall not affect any of the remaining parts, sections, paragraphs, sentences, clauses or phrases of this Ordinance.

SECTION 6. This Ordinance shall become effective immediately after passage and the rates enacted herein shall be imposed on all bills due for months beginning with the first month after passage of this Ordinance, and shall continue in effect until altered or changed by ordinance.
