However, in this instance more effort may be needed to differentiate reality from mirage. This councilwoman's record of pillaged undertaking, consistent with all of the failed goals of her allies in council and those like her in chambers, was not successful nor beneficial to those she fictitiously served. Anticipating and expecting complete, unconditional absolution of self-confessed, willfully obtuse behavior caused when her broken actions were necessarily challenged, considering the chaotic, dysfunctional condition the community has unfortunately been put in almost overnight by herself and her hostile allies, may require something more measurable than a simple statement of shallow sorrow. Aberrant, recalcitrant, demeaning and convoluted behavior requires a systemic, professional counselling interaction and oversight program in order to achieve and then confirm authenticity, progress, believeability, and sincerity. Ms. Suplizio,

The City of DuBois ("the City") acknowledges receipt of your request submitted on January 12, 2025 ("the request") under the Right to Know Law ("RTKL"), Act of February 14, 2008, P.L. 6, 65 P.S. §§ 67.101-67.3104. Upon review, the request is denied.

Under the "records requested" section of the request, the records request in the second to last sentence of the request's diatribe and vituperation advanced against a City councilwoman states as follows:

"In accordance with the State of Pennsylvania's RTK Law, and strictly consistent with HIPAA Privacy Rules, please provide all records, documents, recorded conversations, counselling sessions, and/or agreements in place or planned to properly and effectively rehabilitate and then monitor this rehabilitation of this public official's disguised behavior, and who and how this retalitory (sic) personality will be monitored in order to 'move forward.' And be consistent with leadership expectations historically realized and provided in the past to the citizens of DuBois."

"The burden of proving a record does not exist . . . is placed on the agency responding to the right-to-know request . . . [, and] an agency may satisfy its burden of proof that it does not possess a requested record [by] . . . a sworn affidavit of nonexistence of the record." *Hodges v. Pa. Dep't of Health*, 29 A.3d 1190, 1192 (Pa. Commw. 2011). Furthermore, "[w]here . . . no evidence has been presented to show that [an agency] acted in bad faith, the averments in [the agency's] affidavit[] should be accepted as true." *McGowan v. Pa. Dep't of Envtl. Prot.*, 103 A.3d 374, 382-83 (Pa. Commw. 2014).

Here, as evidenced in the attached affidavit of Benjamin Kafferlin, Interim City Manager for the City, the "records" requested do not exist. Therefore, the request is denied.
