Ms. Suplizio,

The City of DuBois ("the City") acknowledges receipt of your request submitted on January 1, 2025 ("the request") under the Right to Know Law ("RTKL"), Act of February 14, 2008, P.L. 6, 65 P.S. §§ 67.101-67.3104. Upon review, the request is denied.

Under the "records requested" section of the Standard Right-to-Know Law Request Form, the request states:

"In the past two decades, the City of DuBois, Pennsylvania has had significant improvements to its facilities making it known as 'The best place to live – The best place to work.'

Among other things, the city has significantly improved its public athletic facilities.

Considering these unquestionable state-of-the-art facilities, please advise the economic windfalls, that is the economic effects of these athletic facilities and what these improvements have economically meant to the local community economy.

Provide the economic study and economic results that these facilities and their related events have brought to various vendors and local merchants, as well as to the city itself, for each year, 2014 thru 2023 inclusive.

Please provide all records, studies, and reports."

"The burden of proving a record does not exist . . . is placed on the agency responding to the right-to-know request . . . [, and] an agency may satisfy its burden of proof that it does not possess a requested record [by] . . . a sworn affidavit of nonexistence of the record." *Hodges v. Pa. Dep't of Health*, 29 A.3d 1190, 1192 (Pa. Commw. 2011). Furthermore, "[w]here . . . no evidence has been presented to show that [an agency] acted in bad faith, the averments in [the agency's] affidavit[] should be accepted as true." *McGowan v. Pa. Dep't of Envtl. Prot.*, 103 A.3d 374, 382-83 (Pa. Commw. 2014).

Here, as evidenced in the Affidavit of Benjamin Kafferlin, Interim City Manager for the City, the records requested – "the economic study and economic results that [athletic] facilities and [the facilities'] related events have brought to various vendors and local merchants, as well as to the city itself, for each year, 2014 thru 2023 inclusive" – do not exist.

Therefore, the request is denied.

If you wish to appeal the denial of your request, you must file an appeal with the Pennsylvania Office of Open Records within fifteen (15) days from the date of this written response issued by the City. Further instructions for filing an appeal to the Pennsylvania Office of Open Records can be found at https://www.operecords.pa.gov.
