Ms. Suplizio,

The City of DuBois ("the City") acknowledges receipt of your request submitted on January 19, 2025 ("the request") under the Right to Know Law ("RTKL"), Act of February 14, 2008, P.L. 6, 65 P.S. §§ 67.101-67.3104. Upon review, the request is denied.

The request seeks the "2023 audit".

"The burden of proving a record does not exist . . . is placed on the agency responding to the right-to-know request . . . [, and] an agency may satisfy its burden of proof that it does not possess a requested record [by] . . . a sworn affidavit of nonexistence of the record." Hodges v. Pa. Dep't of Health, 29 A.3d 1190, 1192 (Pa. Commw. 2011). Furthermore, "[w]here . . . no evidence has been presented to show that [an agency] acted in bad faith, the averments in [the agency's] affidavit[] should be accepted as true." McGowan v. Pa. Dep't of Envtl. Prot., 103 A.3d 374, 382-83 (Pa. Commw. 2014).

Here, as evidenced in the affidavit of Lisa Hagberg, Interim City Manager for the City, no records exist which are responsive to the request, as the City is not yet in possession of the 2023 audit by the City's auditors. Accordingly, the request is denied.

If you wish to appeal the denial of your request, you must file an appeal with the Pennsylvania Office of Open Records within fifteen (15) days from the date of this written response issued by the City. Further instructions for filing an appeal to the Pennsylvania Office of Open Records can be found at https://www.operecords.pa.gov.
